Welcome to Tony West Art. These Terms of Service govern your use of our website and the purchase of artwork and services from artWestScotland. By accessing our website or making a purchase, you agree to these terms.

1. Acceptance of Terms

By accessing or using our website, you agree to be bound by these Terms of Service and all applicable laws and regulations. If you do not agree with any of these terms, you are prohibited from using or accessing this site.

2. Use of Website

You may use our website for lawful purposes only. You agree not to:

- Use the site in any way that violates applicable laws

4. Pricing and Payment

All prices are listed in British Pounds (GBP) and include applicable taxes unless otherwise stated. Payment is processed securely through Stripe. By providing payment information, you represent that you are authorized to use the payment method.

5. Commissions and Custom Work

Commissioned artwork requires a 50% deposit before work begins. The remaining balance is due upon completion and before delivery. Commission details will be agreed upon in writing before work commences. Cancellation policies:

- Cancellation within 48 hours of commission agreement: Full deposit refund
- Cancellation after work has begun: Deposit forfeited
- Revisions: Up to 2 minor revisions included; additional revisions may incur fees

6. Shipping and Delivery

Shipping costs are calculated based on destination and artwork size. Delivery times vary by location:

- UK: 3-5 business days
- Europe: 5-10 business days
- International: 10-20 business days

All artwork is carefully packaged to ensure safe delivery. Tracking information will be provided once shipped.

7. Returns and Refunds

Due to the unique nature of original artwork, returns are accepted only if:

- The artwork arrives damaged (must be reported within 48 hours with photos)
- The artwork is significantly different from the description

Custom commissioned pieces are non-refundable unless damaged during shipping. Print sales may be returned within 14 days in original condition.
